## Separation & Divorce—Applications

### Worksheet: Custody/Visitation Schedule

Listed below are some suggestions to get you thinking about possible ways to share custody of your child(ren) following divorce or separation. These suggestions are by no means exhaustive, but rather are illustrative of the various options available. This worksheet can serve as a tool to help you and your co-parent work out a compromise relating to the custody and visitation of your children. Any arrangement that works for you and your child(ren) is a good one.

**Check all that apply:**

- Mother / Father (circle one) will have sole legal custody of the child(ren).
- Mother / Father (circle one) will have joint legal custody of the child(ren).
- Mother / Father (circle one) will have sole physical custody of the child(ren).
- Mother / Father (circle one) will have joint physical custody of the child(ren).
- Mother / Father will have primary physical custody of the child(ren), with the other parent having liberal visitation with the child(ren).

**Shared physical custody arrangements:**
